

參、關於國際專修部 About International Foundation Program

一、修業期間:華語先修課程 1年,大學部課程 4年,共修業 5年,始得畢業。

Duration of Study: 1 year for the Chinese preparatory course, 4 years for the undergraduate program, totaling 5 years to be eligible for graduation.

二、華語先修生統一由國際專修部輔導學生生活、經濟、學習、學習成效追蹤及就業輔導。

International students will receive comprehensive support from the International Foundation Program, including guidance on their daily life, financial matters, academic progress tracking, and career counseling.

- 三、依教育部核定本校 3 系所:旅館管理系、餐飲系、資訊管理系,招收學生。 According to the Ministry of Education's approval, our university offers admissions to three departments: Hotel Management, Culinary Arts, and Information Management."
- 四、華語先修期間最長以1年為原則,期間修讀華語課程每週至少15小時以上之華語課程,1 年至少達720小時以上。

The maximum duration for the Chinese preparatory period is typically one year, during which students are required to take Chinese language courses for a minimum of 15 hours per week, totaling at least 720 hours over the course of one year.

五、學生於華語先修期間或期滿後,應達華語文能力測驗Test of Chinese as a Foreign Language (以下稱TOCFL)之聽力與閱讀測驗基礎級(A2)標準,符合語言能力標準後,可接續修讀原錄取系所。

After completing the Chinese preparatory period or during it, students are required to attain at least the A2 level standard in the Test of Chinese as a Foreign Language (TOCFL) for listening and reading comprehension. Once they meet the language proficiency requirements, they can proceed to study in their originally admitted department.

- 六、承上,學生如未達 TOCFL A2 標準,由學校通報退學,學生須依規定離境。
 - Continuing from the previous information, if students do not meet the TOCFL A2 standard, the university will report their withdrawal, and students must follow the regulations for departure.
- 七、學生於大學二年級前應達 TOCFL B1 標準,學生如未達上述標準,由學校通報退學,學生須依規定離境。

Students are required to achieve at least the TOCFL level B1before their sophomore year in university. If students do not meet this standard, the university will report their withdrawal, and they must follow the regulations for departure.

八、華語先修期間不得轉系或轉學,但於正式修讀學士班專業課程1年後,得於旅館管理系、 餐飲系、資訊管理系等三系轉系或轉學。

During the Chinese preparatory period, students are not allowed to transfer to another department or university. However, after completing one year of undergraduate programs, students may request to transfer to one of the three departments: Hotel Management, Culinary Arts, or Information Management.

九、國際專修部學生在規定修業期限內修滿畢業應修學分數且成績優異者,得依大學法第26 條第條第2項規定准其提前畢業。 International Foundation Program students who complete the required credits and achieve excellent grades within the prescribed period of study may be eligible for early graduation in accordance with Article 26, Paragraph 2 of the University Act.

伍、申請資格 Application qualifications

一、申請國際專修部者需符合下列要求

Applicants to the International Foundation Program must meet the following requirements:

(一)符合「外國學生來臺就學辦法」所定外國學生身分。

Meet the qualifications as stipulated in the 'Regulations Regarding International Students Undertaking Studies in Taiwan.'"

(二)具我國教育部認可或當地國政府權責機關或專業評鑑團體認可等官方單位認證之國外高中畢業或以上學歷。

Hold a foreign high school diploma or higher educational qualifications that are officially recognized by the Ministry of Education in Taiwan or by responsible government agencies or accredited professional evaluation organizations in their home country.

(三)具有與我國學制相當之同等學力資格者。

Have qualifications that are equivalent to the educational level in Taiwan.

二、應屆畢業生申請者,申請時可不須繳交畢業證書,如經錄取,須於開學註冊時繳交學歷 證件正本及歷年成績單,否則取消錄取資格。

Applicants who are recent graduates may not be required to submit their graduation certificates at the time of application. However, if admitted, they must provide the original educational documents and transcripts during the registration period at the start of the school year. Failure to do so may result in the cancellation of their admission.

陸、申請方式(一律免申請費) Application method (Free of charge)

- 一、入學申請資料檢核表。Admission Application Document Checklist
- 二、入學申請相關表件(附件1~10)。Admission Application Related Documents (Attachments 1 to 10)
- 三、護照影本。 Photocopy of passport
- 四、經我國駐外使領館、代表處、辦事處或其他經外交部授權機構驗證,或由原修業學校提 出之外國學校高中畢業證書或同等學力證明文件及歷年成績單(中、英文以外之語文, 應附中文或英文譯本)。

Foreign high school graduation certificates or equivalent educational qualifications, as well as transcripts (for languages other than Chinese or English, a Chinese or English translation should be provided), verified by a Taiwanese embassy, representative office, or other authorized agency designated by the Ministry of Foreign Affairs, or submitted by the original educational institution.

五、由金融機構提出足夠在臺就學之財力證明。請提供美金3,000元或新臺幣10萬元的財力證明,或依各國臺灣經濟文化辦事處或大使館規定之最低財力證明金額為準。

Provide financial proof from a financial institution demonstrating sufficient funds for studying in Taiwan. Please provide a financial statement of at least \$3,000 USD or NT\$100,000 NTD or follow the minimum financial proof amount specified by the Taiwan Economic and Cultural Office or Embassy in your respective country.

六、最近三個月內醫院出具之健康檢查證明書一份(收到錄取信後再辦理即可)。

A health examination certificate issued by the hospital within the past three months (you can apply after receiving the admission letter).

七、請將上述文件掃描後,寄至emoiss@gm.tut.edu.tw,正本於開學後繳交。

Please scan the above documents and send them to emoiss@gm.tut.edu.tw. The originals will be submitted after the semester starts.

柒、錄取標準 Recruitment standards

一、持高中學歷或具有教育部「入學大學同等學力認定標準」與我國學制相當之同等學力資 格,具學士班入學資格者。

Applicants holding a high school diploma or possessing qualifications equivalent to the "Admission to Universities for Higher Education Recognition Standards" by the Ministry of Education, which are equivalent to the educational level in Taiwan, are eligible for admission to the undergraduate program.

二、書面資料通過校內審核後,並安排線上面試,以英文或透過翻譯以申請人母語進行訪談,以確定申請人符合本校人才培育目標,始得予以錄取,並由本校寄出入學許可通知。

After the review of the written materials by the university, applicants will be scheduled for an online interview, which can be conducted in English or in the applicant's native language with translation if necessary. This interview is conducted to ensure that the applicant aligns with the university's educational goals. Admission will be granted based on the interview results, and the university will send out admission notifications.

拾壹、錄取通知 Admission notice

- (一)申請人所申請之學系審核通過者,依所填志願序順序錄取,正取至多錄取一學系。 Applicants who pass the departmental review for the applied program will be admitted based on their stated preferences in order of priority, and they will be admitted to a maximum of one department as their first choice.
- (二)本校國際專修部學生之入學申請,由各系(所)依其訂定之入學標準進行初審,招 生委員會就初審通過名冊予以複審,審查合格錄取之外國新生名冊報請校長核定 後,由國際暨兩岸事務處發給錄取生錄取通知。

The admission applications of international students to our university's International Foundation Program are subject to initial review by each department (or program) based on their established admission criteria. The Admissions Committee conducts a secondary review of the list of applicants who passed the initial review. Upon approval, the list of foreign freshmen who have passed the review is submitted to the university president for final confirmation. Admission notifications are then issued to the admitted students by the Office of International and Cross-Strait Affairs.

- (三)錄取生收到錄取通知後,應於規定時間內回覆國際暨兩岸事務處入學本校之意願。 After receiving the admission notification, admitted students should respond to the Office of International and Cross-Strait Affairs within the specified time to confirm their intention to enroll at the university.
- (四)本校確認錄取生有入學意願後,即由國際暨兩岸事務處將入學許可以電子郵件方式 及紙本方式寄送給新生。

After the university confirms that admitted students have the intention to enroll, the Office of International and Cross-Strait Affairs will send the admission letter to the new students via email and in paper format.

(五)國際專修部學生入學申請之結果,原則於本校國際暨兩岸事務處受理申請後10個工作天內通知申請人(假日順延);申請人如於交件20個工作天後,未接獲本校通知者,請逕洽本校國際暨兩岸事務處查詢。

The results of admission applications for the International Foundation Program students will be notified to applicants within 10 working days after the Office of International and Cross-Strait Affairs at the university receives the application (holidays excluded). If applicants have not received notification from the university after 20 working days of submitting their application, they should contact the university's Office of International and Cross-Strait Affairs for inquiries.

(六)外國學生註冊時,新生應檢附已投保自入境當日起至少6個月效期之醫療及傷害保險,在校生應檢附我國全民健康保險等相關保險證明文件。前項保險證明如為國外所核發者,應經駐外館處驗證。

When registering as a foreign student, new students should provide proof of medical and accident insurance coverage with a validity period of at least 6 months from the date of entry. Current students should provide relevant insurance documents such as Taiwan's National Health Insurance. If the insurance certificate is issued abroad, it should be verified by the diplomatic mission or representative office abroad.

拾貳、報到與註冊入學 Registration and enrollment

(一)國際專修部學生接到入學許可後,應依規定程序辦理報到及註冊手續,逾期未辦理報到者,即以自動放棄入學資格論,但事前以書面提出延期申請並經許可者,不在

此限。

International Foundation Program students who receive their admission letters should follow the prescribed procedures for registration and enrollment. Those who fail to register within the specified time will be considered as voluntarily giving up their admission status. However, exceptions may be granted to those who submit a written request for an extension in advance and receive approval.

(二)國際專修部學生經入學後,如發現有申請文件資格不符、偽造、假借、塗改等情事,一經查明即開除學籍,亦不發給任何學歷證件;如於畢業後始發覺者,除勒令繳銷其畢業證書外,並公告取消其畢業資格。

International Foundation Program students who, after enrollment, are found to have submitted application documents that do not meet the qualifications, have been forged, falsified, or altered in any way, will have their enrollment revoked once verified. No academic credentials will be issued. If such discrepancies are discovered after graduation, in addition to revoking their graduation certificate, their graduation qualification will be publicly revoked.

(三)國際專修部學生來臺註冊後,需配合參加本校新生體檢。

After registering in Taiwan, International Foundation Program students are required to participate in the university's new student health check.

拾參、其他申請注意事項 Other notes

一、應屆畢業生申請者,申請時可不須繳交畢業證書。<u>如經錄取,須於開學註冊時繳交學歷</u> 證件正本及歷年成績單,否則取消錄取資格。

Recent graduates applying for admission may not be required to submit their graduation certificates at the time of application. However, <u>if admitted, they must provide the original educational documents and transcripts during the registration period at the start of the school year. Failure to do so may result in the cancellation of their admission.</u>

二、外國學生申請來臺就學,<u>以一次為限</u>。於完成申請就學之學校學程後,除申請碩士班以 上學程,得逕依本校規定辦理外,如繼續在臺就學者,其入學考試應與我國內一般學生 相同。外國學生申請來臺就讀學士班以下學程,在國內停留未滿一年,因故退學或喪失 學籍,得重新申請來臺就學,並以一次為限。

Foreign students applying to study in Taiwan are allowed <u>one opportunity</u> for their initial application. After completing the program for which they initially applied, they may apply for master's or higher-level programs at our university according to our regulations. If they wish to continue studying in Taiwan, they must undergo the same admission examination process as local students. Foreign students applying to study bachelor's or lower-level programs in Taiwan, staying in the country for less than one year, and subsequently withdrawing or losing their student status due to unforeseen circumstances, may reapply for study in Taiwan, with only one additional opportunity.

三、依教育部規定,外國學生凡曾遭國內大專院校以操行、學業成績不及格或因犯刑事案件 經判刑確定致遭退學者,不得再經由本管道申請入學。違反此規定並經查證屬實者,撤 銷其所獲准入學資格。

According to the regulations of the Ministry of Education, foreign students who have been expelled from domestic colleges or universities due to misconduct, unsatisfactory academic performance, or criminal convictions resulting in imprisonment are not eligible to apply for

admission through this program. Violations of this regulation that are substantiated through investigation will result in the revocation of their admission eligibility.

四、外國學生來臺就學後,其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回 復中華民國國籍者,喪失國際學生身分,應予退學。

Foreign students studying in Taiwan who are permitted to establish household registration, transfer their household registration, naturalize, or regain Republic of China (Taiwan) citizenship during their period of study will lose their international student status and will be required to withdraw from the program.

五、依教育部規定,外國學生註冊時,新生應檢附已於國外投保自入境當日起六個月以上效期之醫療及傷害保險,否則本校將依教育部規定請學生強制投保短期保險。

According to the regulations of the Ministry of Education, foreign students registering at the university should provide proof of medical and accident insurance coverage with a validity period of at least six months from the date of entry into Taiwan. Otherwise, the university will require students to enroll in short-term insurance coverage as mandated by the Ministry of Education.

六、入學申請表之電子郵件及聯絡電話請務必填寫正確。本校將依情況所需聯絡申請者,如申請者未能於期限內回覆,視同放棄本身之權益。

Please ensure that the email address and contact phone number provided on the admission application form are accurate. The university will contact applicants as necessary, and failure to respond within the specified time will be considered as the applicant forfeiting their own rights.

七、申請文件一概不退還,請自行保留備份。

All application documents will not be returned, so please retain your own copies for reference.

八、學雜費收退費標準及欠費處理機制依依據「台南應用科技大學學雜與相關費用繳費及退費作業規範」及「專科以上學校學雜費退費基準表」相關規定辦理。

Tuition and fee collection, refund standards, and handling of outstanding fees will be conducted in accordance with the "Tainan University of Technology Tuition and Related Fee Payment and Refund Procedures" and the "Refund Standards for Vocational Colleges and Higher Education Institutions" regulations.

九、各學系(程)畢業應具備之總學分數依各學系時序表為準。

The total number of credits required for graduation in each department or program is based on the respective department's curriculum schedule.

十、本校辦理招生入學,需依個人資料保護法規定,取得並保管申請人個人資料,在辦理招生事務之目的下,進行處理及利用。本校將善盡善良保管人之義務與責任,妥善保管學生個人資料,僅提供招生相關工作目的使用。凡報名本校入學申請,即表示同意授權本校,得將自學生報名參加本招生所取得之個人及相關成績資料,運用於本校招生事務使用,並同意本校提供其報名資料及成績予學生本人及辦理新生報到或入學資料建置。The university complies with the Personal Data Protection Act and obtains and maintains applicants' personal information for the purpose of admissions. The university is committed to responsibly and securely managing students' personal information and will only use it for admission-related purposes. By applying for admission to the university, applicants authorize the university to use the personal and related academic information obtained during the application process for admission purposes and agree to allow the university to provide their application and academic information to the students themselves for registration and

enrollment purposes.

Students from international schools with which the university has signed a "Double Degree Program Agreement".

(二)與本校簽署學術交流合作協議學校或機構推薦之學生。

Students recommended by schools or organizations that have signed academic exchange and cooperation agreements with the university.

- (三)依據「外國學生入學申請辦法」核准入學之學生,但不含該辦法所稱之選讀生。 Students approved for admission in accordance with the "Regulations for the Admission of Foreign Students" excluding those referred to as exchange students in these regulations.
- 三、申請條件及獎助種類 Application Requirements and Types of Scholarships:

First-year students in the seven-year program who register for the first semester will receive a scholarship of NT\$15,000 as a fee exemption for tuition and miscellaneous fees. Those who complete registration for the second semester will receive a scholarship of NT\$10,000.

4. 碩士班一年級新生,第一學期註冊,學雜費抵免新台幣1萬5仟元;完成第二學期註冊者,第二學期獎助新台幣1萬元。

First-year graduate students who register for the first semester will receive a scholarship of NT\$15,000 as a fee exemption for tuition and miscellaneous fees. Those who complete registration for the second semester will receive a scholarship of NT\$10,000.

- (二)成績優秀獎助 Excellence in Academic Performance Scholarship:

Students with a conduct score of 90 or above in the previous semester and ranked in the top 5% of the class for academic performance will receive a scholarship of NT\$50,000.
