TUTech Regulations on Scholarship for Foreign Students

Approved in the administration meeting on May 21st, 2009 Amended in the administration meeting on February 17th, 2011 Amended in the administration meeting on October 20th, 2011 Amended in the administration meeting on June 25th, 2012 Amended in the administration meeting on June 22nd, 2017 Amended in the administration meeting on September 24th, 2020

Article 1

The purpose of the regulations is to encourage excellent foreign students and support them to complete their study at Tainan University of Technology (hereinafter, TUTeach).

Article 2

Foreign students are defined as 1.) those students study in dual-degree international study program offered by TUTech, 2.) those are from contracted schools abroad or recommending by contracted oversea organizations, or 3.) students study at TUTech via the "Regulations of Foreign Students Applying to TUTech", excluding elective students as defined in Article XII (who are overseas Chinese and R.O.C. citizens).

Article 3

For scholarship of outstanding performance, the application requirements are as follows:

- 1. Incoming students who intend to complete a 4 year Bachelor program, as 1st year students, (freshman) will receive NT 25,000 dollars for 1st semester, with the condition that they study for **one academic year**. Incoming students who intend to study for a 2 year Bachelor program, including dual-degree program, and transferred students for a 4 year Bachelor program, which is 1st year in TUTech but with Junior or other status, will receive NT 10,000 dollars for 1st semester. Incoming students who intend to complete a 7 year Bachelor program, as 1st year students, (freshman) will receive NT 25,000 dollars for 1st semester, with the condition that they study for **one academic year**. Incoming students who intend to complete a 2 year Master program, as 1st year students, (freshman) will receive NT 25,000 dollars for 1st semester, with the condition that they study for **one academic year**. The scholarship will be awarded after registration of the second semester. Students who register for a 2nd year will be eligible for article 3-2.
- 2. Continuing students (1) whose academic and conduct grades are both 80 points and above, and also meet top 15% of class ranking qualify to award NT 10,000 dollars, (2) whose academic and conduct grades are both 85 points and above, and also meet top 10% of class ranking qualify to award NT 25,000 dollars, (3) whose academic and conduct grades are both 90 points and above, and also meet top 5% of class ranking are eligible to award NT 50,000 dollars. Continuing master's degree students whose academic and conduct grades are both 85 points and above qualify to award NT 25,000 dollars.
- 3. Students who study for 4 year Bachelor program can only apply up to 4 academic years, and students who study for 2 year Bachelor program can only apply up to 2 academic years. Students who study for 7 year Bachelor program can only apply up to 7 academic years, and students who study for 2 year Master program can only apply up to 2 academic years. Students who transferred from other higher institutions to study 4 year Bachelor program can only apply up to 3 academic years.

Article 4

This scholarship is not available to those who've already received any type of government or private organization's scholarship. TUTech received right to demand students to return the award if

students received any other type of the scholarship.

Article 5

The scholarship of outstanding performance begins a month after the semester starts. The student, who applies article 3-2, must hand in academic and conduct reports, class ranking certificate for the last semester, and the receipt of tuition and fees. The new coming student, who applies article 3-1, must turn in both previous and current semester's the receipts of tuition and fees. The International Affairs Center of Office of Research and Development handles the application and the collection of the document for the Office of Accounting completes the procedure.

Article 6

TUTech received the right to regulate the number and the amount of recipients.

Article 7

This article is not available for those students who are from overseas contracted schools where the contract included the scholarship regulation already.

Article 8

The budget of the scholarship is to come from the following sources:

- (1) The aids from the Ministry of Education.
- (2) The related article of the school.

Article 9

The above regulations were approved in the administration meeting and endorsed by the President of TUT and may be revised by the same process.
