## 貳、申請資格/ Application Eligibility

一、外國學生申請資格係依教育部「外國學生來臺就學辦法」之規定,辦法如經修訂,將 以教育部公告為準。有關教育部「外國學生來臺就學辦法」之最新消息,申請者請隨 時查閱中華民國教育部網站。

All rules and regulations indicated in this admission handbook regarding the qualifications for international students are subject to the "*Regulations Regarding International Students Undertaking Studies in Taiwan*" administered by Ministry of Education (MOE), R.O.C. Should there be any future revisions made in the regulations, the latest regulations announced by MOE, R.O. C. shall prevail. 二、申請人資格:符合下列身份資格者,始具備外國學生申請入學之資格。

Applicant Eligibility: Anyone who satisfies the following requirements may apply for admission

- (一) 具外國國籍且未曾具有中華民國國籍,符合下列規定者,得依本辦法規定申請入學:
   A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations
  - 1. 未曾以僑生身分在臺就學。

The person has never undertaken studies in Taiwan as an overseas Chinese student. 2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發

The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

(二)具外國國籍並符合下列規定,且最近連續居留海外六年以上者,亦得依本辦法規定申請 入學:

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. 1.申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。

A person shall have never had household registration in Taiwan since birth.

 2.申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失 中華民國國籍之日起至申請時已滿八年。

A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least 8 years before making their application

3.前二款均應符合前項第一款及第二款規定。

A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

(三)具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、 澳門或海外連續居留滿六年以上者。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations.

 自為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外六年以 上者。

A person who was formerly from the Mainland Area and who has foreign nationality and has have never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution.

2.本校教學以華語文為主,申請人須具備相當於華語文能力測驗(TOCFL)A2(含)以 上之華語文能力檢定證明,或提出前段學歷為主修華語文或以華語文授課為主之畢 業證書等證明。申請應用英語系時,須提出相當於CEFR B1(含)以上或等同之英語 認證考試證明。

All subjects are mainly taught in Mandarin Chinese. Applicants must have a Chinese language proficiency test certificate equivalent to Level A2 or above of the Test of Chinese as Foreign Language (TOCFL), or a graduation certificate with previous academic qualifications majoring in Chinese language or subjects taught mainly in Chinese language. For applying for the Department of Applied English, applicants need to submit an official English proficiency certificate which is equivalent to CEFR B1 level.

- (四) 須符合各學制之入學資格 Requirements to apply for a program:
  - 符合我國教育部採認之高中、專科、大學或獨立學院畢業:申請學士班者需具國 外高中畢業學歷;申請碩士班者需具大學畢業學歷。

To apply for a bachelor's program, a foreign high school diploma is required. To apply for a master's program, a bachelor's diploma is required. To apply for a doctoral program, a master's diploma is required. Diplomas must be issued by schools recognized by the R.O.C. Ministry of Education.


2.持同等學力申請入學者,其同等學力認定標準應符合我國教育部公告之「入學大學同等學力認定標準」。

The assessment and recognition of academic credentials at an adequate level of education should be conducted in accordance with the MOE *Standards for Recognition of Equivalent Educational Levels for University Admission*.

- 3.欲申請就讀學士班者,須未曾在我國以外國學生身分申請並完成高中學校學程。 Applicants who have completed secondary education in the Republic of China are not eligible to apply to bachelor degree programs as foreign students.
- 4. 具國中畢業資格之外國學生或具國中畢業資格且在臺已有合法居留身分之外國學生,得申請入學本校七年一貫制。

Foreign students who have graduated from a junior high school, or foreign students who have graduated from a junior high school and have legal residence status in Taiwan, are eligible to apply to the seven- year consistent program.

## 冬、申請流程 Application Procedures



#### 肆、修業年限 Prescribed Duration of Study

一、根據本校學則第二篇第三章第二十五條規定,本校採學年學分制,四年制各系修業年限四年,所修學分總數至少須修滿一百二十八學分;二年制各系修業年限二年,所修學分總數至少須修滿二百八一十學分,各系得視實際需要經教務會議通過提高應修學分總數。學生在規定修業年限內, 未能修足應修學分者,至多得延長修業年限二年。

Based on Rule 25, Chapter 3, Part 2 of *Tainan University of Technology Academic Regulations*, TUT adopts the credit system and the academic year. The duration of four-year program is four years. The total credits are required to be at least 128 credits; the duration of two-year program is two years. The total credits are required to be at least 72 credits; the duration of seven-year consistent program is seven years. The total credits are required to be at least 280 credits. one who fails to complete in such period the credits, courses, or other criteria for graduation is a student of deferred graduation, who may apply to extend their study period for a maximum of two years.

二、身心障礙學生修讀學士學位,因身心狀況及學習需要,得延長修業期限,至多四年,並不 適用因學業成績退學之規定。

The students with disabilities who can submit the appropriate evidences (e.g., Disability ID; Special Education Students Diagnosis and Placement Certificate) issued by the competent authorities may apply for a further extension of study for up to two years.

- 三、學生因懷孕、分娩或撫育三歲以下子女之需要,得延長修業期限。 The students under the conditions such as pregnancy, childbirth, or childcare for infant(s) or toddler(s) under age of three are able to apply for a further extension of study.
- 四、 持國外或香港、澳門高級中等學校學歷,畢業年級相當於國內高級中等學校二年級之國外 或香港、澳門同級同類學校畢業生,以同等學力報考之四年制學生,於原學分總數外,應 增修至少十二個錄取科系之專業選修學分。

Applicants who completed high school at an overseas (including Hong Kong and Macau) school that is equivalent to a 11 grade of senior high school in Taiwan may apply for an undergraduate program at Tainan University of Technology. However, these students must complete at least 12 extra credits of professional selected courses at the admitted department.

五、根據本校學則第三篇第三章第六十七條規定,碩士班修業年限以一至四年為限。在職進修 研究生未在規定修業期限修滿應修課程或未完成學位論文者,因特殊需要得酌予延長修業 期限以一年為限。

Based on Rule 67, Chapter 3, Part 3 of *Tainan University of Technology Academic Regulations*, the period of study for **a master degree is one to four years**. The students who fails to take all requires or to finish thesis on-the-job training may apply for a further extension of study for one year.

The highest-level diploma and transcript issued by an overseas academic institution. These documents must be authenticated by an ROC embassy, consulate, representative office, the agency authorized by the Ministry of Foreign Affairs (hereafter referred to as "Taiwan's overseas representative office"), or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan (a copy of the translation in Chinese or English is necessary if the original diploma is in language other than Chinese or English).

Remarks: If the verification process is not completed before the application deadline, a signed Affidavit (of Admissions Documents to be Verified) (See Appendix IV) shall be submitted with the application. At the time of registration, students must provide the original academic degree and transcript verified by a Taiwan overseas representative office, or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan. If all the required documents cannot be submitted on time, the admissions offer will be revoked.

Students who apply with SMK/SMJK or (Chinese) Independent High School's Transcript required to submit SPM (Sijil Pelajaran Malaysia/Malaysian Certificate of Education/Malaysian Certificate of Educaiton)/ STPM (Malaysian Higher School Certificate), or UEC (Unified Examination certificate) which shall be authenticated by a ROC embassy, consulate, representative office, the agency authorized by the Ministry of Foreign Affairs (hereafter referred to as "Taiwan's overseas representative office"), or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan (a copy of the translation in Chinese or English is necessary if the original diploma is in language other than Chinese or English).

#### (二)持大陸地區學士學位以上(含)者,另須繳交「學位證(明)書」。

Applicants with the bachelor's degree or above obtaining from the schools in Mainland China which are specifically recognized by MOE are also required to submit the certificate of degree conferral.

   Current graduates are required to submit an official certificate of expected graduation (English or Chinese) issued by the school in lieu of the diploma at the time of application.
- 五、錄取生於辦理報到時,應依以下規定繳交經相關單位驗證之畢業證書,學位證書 (適用於持大陸地區學士及以上學位者)及成績單與其他相關學歷證明文件並辦理 報到,始得註冊入學。

Admitted applicants can enroll only after they have submitted the photocopies of their diploma, certificate of degree conferral (applicable to the applicants with the bachelor's degree or above obtaining from the schools in Mainland China which are specifically recognized by MOE) as well as transcripts and other relevant academic certificates which are all verified by the related offices according to the following regulations.

(一) 持國外學歷者,應依教育部「大學辦理國外學歷採認辦法」規定辦理。

The students whose degrees are conferred by the foreign schools (excluding the schools in Hong Kong, Macau, and Mainland China) shall follow the "Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education".

(二) 持香港或澳門學歷者,應依「香港或澳門學歷檢覈及採認辦法」規定辦理。

The students whose degrees are conferred by the prescribed schools in Hong Kong or Macau shall follow the "Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao" for the requirement of relevant academic certificates.

(三) 持大陸地區學歷者,應依「大陸地區學歷採認辦法」規定辦理。

The students whose degrees are conferred by the schools in Mainland China which are specifically recognized by MOE shall follow the "*The Regulations Governing the Accreditation of Schools in Mainland China*" for the requirement of relevant academic certificates.

- 六、申請人須具備相當於華語文能力測驗(TOCFL)A2 級以上之華語文能力檢定證明, 或提出前段 學歷為主修華語文或以華語文授課為主之畢業證書等證明。申請應用 英語系時,須提出相當於CEFR B1 (含)以上或等同之英語認證考試證明。 Applicants must have a Chinese language proficiency test certificate equivalent to Level A2 or above of the Test of Chinese as Foreign Language (TOCFL), or a graduation certificate with previous academic qualifications majoring in Chinese language or subjects taught mainly in Chinese language. For applying for the Department of Applied English, applicants need to submit an official English proficiency certificate which is equivalent to CEFR B1 level.

If additional materials are required by specific departments, the applicant shall be notified as needed.

#### 捌、 資格審查 Eligibility Review

一律以書面資料審查為主。待申請資料彙整後,國際暨兩岸事務中心先進行資格審查,再送至各學系進行審查,最後經本招生委員會審核後,確定申請人符合本校人 才培育目標,始得予以錄取,並由本校寄出入學許可通知。

The review process will be based on application documents. International and Cross-Strait Affairs Center will check the applicant's eligibility after receiving all application documents, and send it to each department for the faculty review, and the final decision will be made at the Admission Committee meeting. After the Admissions Committee has reviewed and made sure that the applicant meets the school's talent cultivation goals, the applicant will be admitted and an admission notice will be sent from the school.

#### 玖、其他申請注意事項 Others

一、申請人須具備中國語文聽、說、讀、寫能力。

The Chinese proficiency is required in all reading, writing, listening, and speaking.

二、申請人應注意申請資格、申請系所之各項規定。

Applicants may apply for a maximum of three degree programs only (filled in the order of choice) and shall abide by all the application requirements as specified.

三、依教育部規定,凡曾經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確 定致遭退學者,不得再向本校申請入學。若違反此規定並經查證屬實者,取銷其入 學資格。

In accordance with the Ministry of Education regulations, students who had been dismissed from a university or college in the R.O.C. before are not eligible to apply. Applicants who violate this regulation shall have their admissions revoked.

四、已報名或錄取之學生,如經發現申請資格不符規定或所繳交之證件有變造、偽造、 假借、冒用等不實情事者,未入學者即取消錄取資格;已入學者開除學籍,亦不發給 任何學歷證明;如將來在本校畢業後始發現者,除勒令繳銷其學位證書外,並公告 取消其畢業資格。

Admission shall be denied after admission and / or the student shall be dismissed from TUTech without any academic certificate if there are any qualification violations or fakes, counterfeits, feints or impostures of the documents submitted are found. Those who have graduated shall have their diploma revoked.

五、報名時繳交之「畢業證書」,除海外臺灣學校及華僑學校所發者外,應依教育部「國 外學歷查證認定作業要點」規定辦理。

The diploma submitted for review shall be authenticated in accordance with the rules promulgated by the R.O.C. Ministry of Education, except for diplomas issued by overseas Taiwanese schools or overseas Chinese schools.

六、外國學生於就學期間發現檢驗人類免疫缺乏病毒抗體之檢驗報告結果呈陽性反應者 ,依據法令應通知外交部或內政部撤銷或廢止其簽證或停留、居留許可並令其出國 (境)。

During the pursuit of degree, while a student is testified as a HIV-positive, by law, the university shall notify the Ministry of Foreign Affair or the Ministry of the Interior to revoke or annul his / her visas or permits of stay or residence, and order him / her to be deported.

七、所有境外學生入境後均須購買健康保險(台南應用科技大學指定保險單位)。

Students must purchase health insurance, advised by TUTech, in Taiwan.

八、依據疾管局規定,所有外籍生均須提供衛福部指定醫院完成之健檢證明

According to the regulation, students shall have health certificate (form B) when registered which is done by the valid clinic(s).    This scholarship program is designed to provide financial support to outstanding foreign students to assist them in successfully completing their studies at the university.
- 二、本要點所稱之境外學生,係指 The term "foreign students" referred to in this program includes the following categories:

(一)與本校簽署「雙聯學制協議書」之境外學校雙聯學制學生。

Students from international schools with which the university has signed a "Double Degree Program Agreement".

(二)與本校簽署學術交流合作協議學校或機構推薦之學生。

Students recommended by schools or organizations that have signed academic exchange and cooperation agreements with the university.

(三)依據「外國學生入學申請辦法」核准入學之學生,但不含該辦法所稱之選讀生。 Students approved for admission in accordance with the "Regulations for the Admission of Foreign Students" excluding those referred to as exchange students in these regulations.

Those with a conduct score of 85 or above in the previous semester and ranked in the top 10% of the class for academic performance will receive a scholarship of NT\$25,000. Students with a conduct score of 90 or above in the previous semester and ranked in the top 5% of the class for academic performance will receive a scholarship of NT\$50,000.

Students applying for four-year undergraduate programs who are exempted from specific coursework based on their previous academic records will have a maximum scholarship duration of three years.

Students who are enrolled in extension programs or receive other types of domestic scholarships are not eligible to apply for these scholarships. Violations of this rule, if confirmed, may result in the recovery of the scholarship funds.

Students who violate the following rules must return the full amount of the scholarship:

Undergraduate students in four-year programs who have completed at least the first two academic years of study at the university and subsequently withdraw, drop out, or leave school for other reasons must return the entire scholarship.

(二)七技學生至少在本校就讀前四學年之學業,凡休學、退學或其他原因離校者,必須全 數退回。

Undergraduate students in seven-year programs who have completed at least the first four academic years of study at the university and subsequently withdraw, drop out, or leave school for other reasons must return the entire scholarship.

(三)碩士班學生至少在本校就讀前一學年之學業,凡休學、退學或其他原因離校者,必須 全數退回。

Master's degree students who have completed at least the first academic year of study at the university and subsequently withdraw, drop out, or leave school for other reasons must return the entire scholarship.

(四)新生於第一學期辦理休退學者,取消學雜費抵免,學雜費退費基準依「專科以上學校 學雜費收取辦法」辦理。

New students who withdraw or drop out during the first semester will have their tuition and miscellaneous fee exemptions canceled, and the criteria for tuition and miscellaneous fee refunds will be handled in accordance with the "Regulations for the Collection of Tuition and Miscellaneous Fees for Junior Colleges and Above".

Students applying for scholarships based on excellent academic performance must submit the following documents to the International Exchange Center of the Office of Research and Development within one month after the start of each semester, along with proof of payment for the current semester or a certificate of enrollment, and proof of their academic ranking in the previous semester at the university. The International Exchange Center will compile the relevant information and submit it to the relevant departments for further processing.

The amount of scholarships and the number of recipients may be adjusted based on the university's annual budget for scholarships and the proportion of international students in a given academic year.

- 九、已簽訂學術交流合作協議學校之獎助方式,依其合約規範辦理,不受本要點限制。 Scholarships for schools that have signed academic exchange cooperation agreements will be implemented in accordance with the terms of their contracts and will not be subject to the restrictions of these regulations.
- 十、本要點所需經費來源由教育部相關補助款項及本校相關經費項下支出。獎助金名額得依 實際經費預算狀況彈性調整。
   The funding required for these scholarships will be sourced from relevant subsidies from the

Ministry of Education and related expenses of the university. The number of scholarships may be flexibly adjusted based on the actual budget situation.

十一、本要點經行政會議通過,校長核定後實施,修正時亦同。 These regulations have been approved by the Administrative Council and will be implemented upon approval by the university president. They may be revised as needed.
